<u>WASHINGTON STATE PARKS:</u> Holm noted parks are gearing up for the end of the season and Labor Day. Projects will commence during the shoulder season. Outdoor Discover Day was a success; There will be a dedication of the Red Bluff Lighthouse plaque on September 14th. Holm introduced the NW Region Area Manager, Ciera Strickland, who replaces Jon Crimmins.

<u>NATIONAL PARK SERVICE:</u> Lex Fredy reported that there's some movement on the lease of the Pratt field behind the Cottage, with an RFP expected in November. NPS is working to close out the end of the fiscal year by Sept. 30, 2022. There is still no formal directive on Ebey's Reserve from Pacific West Region, but it is expected soon.

UNFINISHED BUSINESS:

Borden moved to Unfinished Business and called on Garratt and Shimada for an update. Shimada said the final draft was sent to NPS Contracting in San Francisco for review.

Shimada then called on Kiyama to introduce Ava Galbraith, Historic Preservation Intern. Chair, Lisa Bernhardt called the meeting to order at 10:01am and welcomed members of the Friends of Ebey's board. <u>NATIONAL PARK SERVICE:</u> Lex Fredy reported NPS is closing out the fiscal year at the end of September; the Delegation of Authority has been received. Administration and management of NPS in the Reserve will now be based out of San Juan; the Servicewide Comprehensive Call will come sometime between October and January; Ferry House roofing work continues; Scott Swenson will be on detail to North Cascades for four months.

TOWN OF COUPEVILLE: Bernhardt reported on some paving projects within the town, including the paving of pathways instead of the gravel. The town comp plan is still underway with a meeting schedule with public comment; and the town interpretive panels at the Rec Hall, Holbrook Boat Shed, and City Hall have been finalized and will be moving forward with production and installation.
